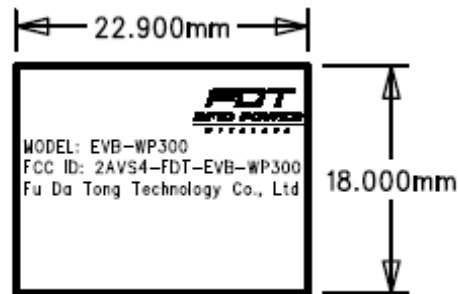
General product information:
